






SN54F86 . . . FK PACKAGE (TOP VIEW)





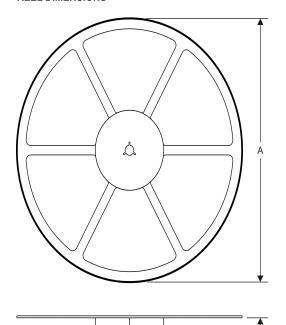
