



Silicon PIN Photodiode

Description

BP104 is a high speed and high sensitive PIN photodiode in a miniature flat plastic package. Its top view construction makes it ideal as a low cost replacement of TO–5 devices in many applications. The epoxy package itself is an IR filter, spectrally matched to GaAs or GaAs on GaAlAs IR emitters (λ_p =950nm). The large active area combined with a flat case gives a high sensitivity at a wide viewing angle.

- Wide angle of half sensitivity $\phi = \pm 65^{\circ}$
- High photo sensitivity
- Fast response times
- Small junction capacitance
- Plastic case with IR filter (λ =950 nm)






Figure 1. Reverse Dark Current vs. Ambient Temperature




Figure 2. Relative Reverse Light Current vs. Ambient Temperature




Figure 3. Reverse Light Current vs. Irradiance




Figure 4. Reverse Light Current vs. Reverse Voltage




Figure 5. Diode Capacitance vs. Reverse Voltage




Figure 6. Relative Spectral Sensitivity vs. Wavelength




Figure 7. Relative Radiant Sensitivity vs. Angular Displacement







- 3. Council Decision 88/540/EEC and 91/690/EEC Annex A, B and C (transitional substances) respectively.
