The TSHA520. series are high efficiency infrared emitting diodes in GaAIAs on GaAIAs technology, molded in a clear, untinted plastic package.

In comparison with the standard GaAs on GaAs technology these high intensity emitters feature about 70 % radiant power improvement.


Infrared remote control and free air transmission systems with high power and long transmission distance requirements in combination with PIN photodiodes or phototransistors.




Figure 1. Power Dissipation vs. Ambient Temperature




Figure 2. Forward Current vs. Ambient Temperature




Figure 3. Pulse Forward Current vs. Pulse Duration




Figure 4. Forward Current vs. Forward Voltage




Figure 5. Relative Forward Voltage vs. Ambient Temperature




Figure 6. Radiant Intensity vs. Forward Current




Figure 7. Radiant Power vs. Forward Current




Figure 8. Rel. Radiant Intensity\Power vs. Ambient Temperature




Figure 9. Relative Radiant Power vs. Wavelength





Figure 10. Relative Radiant Intensity vs. Angular Displacement

Ozone Depleting Substances Policy Statement
